### **Terms & Conditions**

### A. GENERAL INTRODUCTION

- 1. JA Waste Smart Kids ("the Competition") is organized by JA Malaysia ("the Organizer") with the support from First Solar ("the Main Sponsor").
- 2. The Organizer reserves the right to modify the contest mechanisms, withdraw or terminate this competition at any time at its sole and absolute discretion without prior notices to any person.

## B. ELIGIBILITY

The competition is divided into 2 different levels. Details are as follows:

#### C. SUBMISSION REQUIREMENT

To participate, participants must comply with each of the following:

#### 1. **PRELIMINARY ROUND**

- 7. \*Title of (i) Poster or; (ii) Project

\*(Include title "JA Waste Smart Kids" followed by the title of participant's submission)

- Participants can submit their entries either in English OR in Bahasa Malaysia
- All submissions must be the participant's original work and no part or component thereof is copied from any other work or material.

- 1.1 The closing date for Preliminary Round submission is by **5.00 p.m.** on the **30th October 2022**. Entries received after (or such extended closing date determined at the sole and absolute discretion of the Organizer) or are damaged, corrupted, incomplete or illegible will not be accepted and will be disqualified.
- 1.2 The Organizer may at its sole and absolute discretion extend the contest period at any time without any prior notice to any party whatsoever. Unless otherwise varied to the contrary by the Organizer, any participation in the competition during the extended period (if any) shall be governed by the Terms and Conditions set out herein which shall remain in full force and effect at all times.
- 1.3 The Judges will then make a selection of the **Top 20** submissions from both levels (Level 1 and Level 2) in the Preliminary Round.
- 1.4 Only 1 submission per participant will be selected to enter the Final Round.
- 1.5 The **Top 20** chosen submissions will be eligible to enter the Final Round of the competition.
- 1.6 The **Top 20** participants will be contacted via WhatsApp or email to notify them accordingly.

- Participants can submit their entries either in English OR in Bahasa Malaysia
- 2.1 The closing date for Final Round submission is by **5.00 p.m.** on the **18**<sup>th</sup> **of November 2022**. Entries received after (or such extended closing date determined at the sole and absolute discretion of the Organizer) or are damaged, corrupted, incomplete or illegible will not be accepted and will be disqualified.
- 2.2 The Judges will then make a selection of the **Top 5** and the **Top 10** submissions from both categories (Level 1 and Level 2) from the Final Round.
- 2.3 The **Top 5** chosen submissions from the Final Round (Level 1 and Level 2) will be the winners for the competition. The next **Top 10** chosen submissions will win consolation prizes.
- 2.4 Announcements will be made via WhatsApp or email accordingly.

### D. FORMAT OF THE VIDEO SUBMISSION FOR THE FINAL ROUND

- 1. Include Title "JA Waste Smart Kids" followed by the title of participant's submission.
- 2. Video can be in any format as long as the Organizers are able to download and view it.
- 3. No specific requirement on video resolution as long as the content can be seen.
- 4. Audio quality should be clear.
